Who can apply?

The Harper Adams Club Animal & Veterinary Sciences Scholarship is open to all full-time **Year 2 and Year 4** students at Harper Adams University studying the following courses:

- Animal Behaviour & Welfare all undergraduate courses, clinical and non-clinical
- Animal Health & Welfare BSc (Hons)
- Animal Production Science MSci and BSc (Hons)
- Bachelor of Veterinary Medicine and Surgery Harper hosted/based
- Veterinary Bioscience MSci/, BSc (Hons), BSc, BSc Extended
- Applied Zoology all undergraduate courses
- Zoology with Entomology BSc (Hons)
- Zoology with Environmental Management BSc (Hons)
- All Veterinary Nursing courses BSc (Hons), BSc and BSc Extended
- Veterinary Physiotherapy BSc (Hons), BSc and BSc Extended

The Harper Adams Club prefers applicants to have:

- A good academic record whilst at Harper Adams University
- Interest and enthusiasm for your field of study
- The potential to be a good future ambassador for Harper Adams University

Please note that students may only apply for ONE Harper Adams Club Scholarship in an academic year (eg. Animal & Veterinary Sciences or Final Year, but not both awards)

Opportunities

If awarded, the successful recipient will receive a one-off payment valued up to a maximum of £1,250.

The award will be paid in two equal parts; half to be paid in March 2025 and the remaining balance in May 2025. Payment is conditional on the scholar remaining registered as a full-time student at Harper Adams University. They must pass all modules of study during the continuation of the scholarship and submit a letter of thanks for the sponsor to the Development Trust prior to the receipt of each payment.

This is a competitive award which will be evaluated on the merit of the submitted application, academic achievements to date and interview. The Development Trust embraces diversity and promotes equality of opportunity and access to higher education. The Trust has been successful in supporting a wide range of students. It strongly encourages applications from students of all backgrounds. Where there are two

Application Process

Your application must include the following three documents, which should be saved in PDF format, named 1. Consent Form, 2. Covering Letter and 3. CV and emailed to DevelopmentTrust@harper-adams.ac.uk by 12 noon on Friday 24 January 2025. Email subject: HAC AVS Scholarship

- Consent Form this must be completed and signed to show that you have read and understood the Privacy
 Data Protection Notice
- 2. **Application letter** of no more than 500 words, addressed to Mrs Doris Taylor, Director of Development and Alumni Relations, explaining why you would be interested in receiving the Harper Adams Club Scholarship. You may find it useful to refer to the preferred characteristics above.
- 3. **CV** no more than 2 pages

Application Deadline: 12 Noon Friday 24 January 2025.

Shortlisted applicants are required to attend a panel interview on Friday 21 February 2025. (Please note that an alternative interview date <u>cannot</u> be arranged).

How your personal information will be used:
